REGULATORY NOTICE

By virtue of the powers and authority under Act No. 161 of December 1, 2009, as amended, known as the Permitting Process Reform Act of Puerto Rico, and pursuant to the provisions of Section 2133, Act No. 170 of August 12, 1988, as amended, known as the Uniform Administrative Procedures Act, the Permits and Land Use Review Board (hereinafter "Review Board") and the Office of the General Inspector of Permits announce the adoption of the *Rules for the Collection of Fees of the Review Board, and the Rules for the Collection of Service Charges and Fines of the Office of the General Inspector of Permits*, and Administrative Order OA-JR-2010-4, to establish costs and fees to be charged for the filing of appeals for review, copies of documents and other services of the Review Board, and Administrative Order OIGPe-2011-OA-06 to establish collection of service fees at the Office of the General Inspector of Permits.

The purpose of the Rules and Administrative Orders listed above is to establish the processes, costs and fees to be charged for the filing of appeals, copies of documents and other services offered by the Review Board and the Office of the General Inspector of Permits, as applicable. *The Rules for the Collection of Fees of the Review Board was presented to the Department of State on Thursday, December 16, 2010 and the Rules for the Collection of Service Charges and Fines of the Office of the General Inspector of Permits was submitted to the Department of State on February 11, 2011, and they both became effective immediately, pursuant to Section 2133 of Act No. 170, supra.*

The text of the Rules and Administrative Orders will be available for inspection and receipt of written comments during the hours of 8:00 am to 12:00 pm and 1:00 p.m. to 4:00 pm weekdays, with the Secretary of the Review Board, located on the second floor of the Roberto Sánchez Vilella Government Center South Building, Stop 22, Santurce and the Office of the General Inspector of Permits, located on Tenth Floor of the Roberto Sánchez Vilella Government Center North Building, Stop 22, Santurce.
